This bulletin describes the procedures involved in the issuance of an advance ruling which is a statement given by the ministry to a taxpayer, stating how it will interpret provisions of Ontario's Corporations Tax Act, the Mining Tax Act and the Electricity Act, 1998 with respect to a specific transaction which the taxpayer is proposing.

Advance Tax Rulings - Corporations Tax

The Directorate's target is to issue Rulings within a specific period of time starting on the receipt of all information as set out in Appendix A "Advance income tax ruling request checklist and Appendix A.1 "Advance income tax ruling request template. The service standard is 90 business days 80% of the time.
